In August 2020, Andrey Batyukov joined Indosuez Wealth Management as Head of the Eastern Europe Desk with teams in Geneva and Zurich.

Andrey Batyukov is a Swiss citizen and holds degrees from the Moscow Engineering Physics Institute (MEPhI) and the Higher School of Economics University of Russia (HSE). He also holds a Diploma in Banking & Finance from Kalaidos University of Applied Sciences Switzerland.
